SENATOR RICK SCOTT'S LEGISLATIVE ACTION UPDATE

FIGHTING THE FENTANYL CRISIS

- Senator Rick Scott's **Eradicating Narcotic Drugs and Formulative Effective New Tools to Address National Yearly Losses of Life (END FENTANYL) Act** was recently signed into law by the President. The **END FENTANYL Act**:
 - Requires the Commissioner of the U.S. Customs and Border Protection (CBP) to review and update the Office of Field Operations' policies and handbooks in order to respond to illegal activity, such as the trafficking of drugs and humans, along the border.
 - Requires the Commissioner of CBP to submit a report to the Committee on Homeland Security and Governmental Affairs of the Senate and the Committee on Homeland Security of the House of Representatives that summarizes the policy and manual changes every three years.
- **Continuing High-quality Evaluations of Concerning and Known Persons Of Interest through National Training Updates (CHECKPOINT) Act**: This bill codifies and requires regular updates to the Checkpoint Program Management Office so officers can better catch criminals at border checkpoints.
- **School Access to Naloxone Act**: This bipartisan legislation would make it clear that schools are eligible to receive federal overdose prevention funds. No school should be without lifesaving opioid antagonists that can literally stop an overdose in its tracks.
- **Overcoming Prevalent Inadequacies in Overdose Information Data Sets (OPIOIDS) Act**: This bill helps collect better data on overdoses and poisonings across the country so local, state and federal resources can be best targeted to areas with the highest need.
- Senator Rick Scott sent a **letter** to every superintendent in Florida, encouraging them to educate their students on the dangers of fentanyl and other illicit drugs. Since then, our partners have told us about hundreds of new awareness programs they have implemented throughout the state.

FIGHTING TO SECURE OUR BORDER

- Senator Rick Scott **fought on the U.S. Senate Floor** against the radical and unprecedented dismissal of the impeachment of Department of Homeland Security Secretary Alejandro Mayorkas.
- Senator Rick Scott led a **press conference** with Senate conservatives to voice their strong opposition to Democrats' bad "border deal," which did nothing to actually secure our southern border.
- **Upholding the Law at Our Border Act**: Senator Scott introduced this bill, which requires an immediate investigation to ensure the proper vetting and processing of anyone that comes into our country and holds the Biden administration accountable to uphold the law.
- **Keep Our Border Agents Paid Act**: This legislation ensures our brave Border Patrol agents remain fully paid in the event Congress fails to complete its constitutional duty to fund the government. A secure U.S. Border starts with a fully staffed Border Patrol and Congressional in-fighting shouldn't prevent these brave men and women from being able to put food on the table.
